Creating tempting conditions and high wages forces both cheap and unskilled labor working in the lowest cadre positions and specialists who manage and control this unskilled cheap labor to migrate.

Taking into account the above-mentioned factors, it can be concluded that the demand for specialists in transport, procurement, distribution, customs and other types of logistics is always relevant, so specialists in the field of transport of any country in the world strive to start their work on the international market of transport services.

The logistics industry was no exception, so there was a tendency that American transport companies are opening their branches in Ukraine to attract highly skilled labor [2].

Based on the above-mentioned analysis of the American and Ukrainian transport systems, we conclude that the level of development of the American transport system is much higher than the

Ukrainian one, respectively, the minimum wage of specialists in the United States is much higher than that in Ukraine.

Experts in the field of finance note that the profit of any company is formed not through a significant turnover of funds or an increase in profits, but through a decrease in the cost of the direct functioning of the enterprise. Therefore, American transport companies are interested in attracting highly qualified specialists from Ukraine, because the minimum wage for a logistics manager in the labor market in the U.S. will be one of the highest wages in the labor market of Ukraine. Therefore, such cooperation is beneficial to both parties [1].

Conclusion. Cooperation between Ukrainian and American transport systems has a number of positive consequences:

1. Raises the standard of living among specialists in the field of logistics due to high salaries in terms of Ukraine.
2. It is due to the receipt of currency in the country and the payment of taxes on the territory of Ukraine.
3. The direction and contribution of the money received in Ukraine to the further development of the state, which in turn can have a positive effect on the investment attractiveness of the country, because it indicates the government's intentions to develop the country, which gives certain reasons for investors to assume that their funds will eventually return with interest.

The cooperation of Ukrainian and American specialists contributes to the exchange of experience in the management of motor transport enterprises and the borrowing of modern technologies, which results in the introduction of these modern systems and methods of doing business in the transport industry of Ukraine, which eventually turns it into one of the most modern and best developed industries in the country, and this in turn lays a reliable foundation for the further development of Ukraine, since it is without a powerful and developed network of infrastructure facilities that it is impossible to imagine the effective functioning of the economy [5].
